#### **Faculty of Economic Sciences:**

# Examination and study regulations for the consecutive Master's degree programme "Development Economics" at the University of Göttingen

#### § 1 Scope and faculties involved

- (1) The provisions of the "General Examination Regulations for the Bachelor's and Master's degree programmes and other degree programmes offered at the University of Göttingen" (APO) as well as the "General examination and study regulations for Master's degree programmes at the Faculty of Economic Sciences" apply to the consecutive Master's degree programme "Development Economics" at Georg-August Universität Göttingen.
- (2) These regulations stipulate the additional provisions for the Master's degree programme.
- (3) <sup>1</sup>The Master's degree programme "Development Economics" is offered jointly by the Faculty of Economic Sciences and the Faculty of Agricultural Sciences. <sup>2</sup>Umbrella faculty is the Faculty of Economic Sciences. <sup>3</sup>The degree programme is taught in English.

# § 2 Aim of the qualification

(1) ¹The English-taught Master's degree programme "Development Economics" prepares graduates for a career in science as well as government or non-government organisations concerned with development cooperation. ²The degree programme is research-oriented and, aside from the general aims of the Master's programme defined in the RPO-MA, conveys methodological and theoretical knowledge of economics and agricultural economics, which enable graduates to comprehend and critically evaluate scientific literature in order to answer complex questions of micro- and macro-development economics as well as agricultural

economics. <sup>3</sup>Depending on the chosen area of specialisation, students deal intensively with contemporary empirical literature in development and political economics, methods of causal inferencing and poverty and inequality research; or else they advance their knowledge and skills with regard to the functional dynamics of global agricultural markets, rural development, and the evaluation of interventions and policies in agricultural societies. <sup>4</sup>Moreover, the students' creation of an individual area of specialisation composed of compulsory elective modules and elective modules is possible and encouraged; the broad offer of courses allows students to specialise in methodology (econometrics/statistics), certain sub-fields of development economics like gender, health, education or behavioural economics, or to acquire special knowledge on the development, history and language of individual regions (e.g., Latin America, Africa, India). <sup>5</sup>Compulsory modules as well as the master's thesis are designed to convey and advance students' knowledge and skills in the practice of independent scientific work; furthermore, the potential participation in research projects through fieldwork visits abroad allows students first insights into empirical development-economic research and specifically into the collection and evaluation of primary field data.

(2) <sup>1</sup>The competences thus acquired prepare graduates of the Master's degree programme "Development Economics" for many different tasks in elevated positions: to work as planners and advisors for the implementation of policies in development cooperation in national government organisations; to evaluate such policies in research and evaluation institutions; to investigate the efficiency of development aid on behalf of national and international donor organisations; to plan, organise and implement interventions for the improvement of living situations of people living in underdeveloped regions, working for non-government organisations; to analyse markets of developing and emerging countries, working in banks, insurances and rating agencies; or to conduct doctoral studies and more in development economics at renowned universities in Germany and abroad. <sup>2</sup>Typical employers for graduates of the Master's degree programme "Development Economics" include national institutions within development cooperation (GIZ, KfW or BMZ), international organisations (World Bank, UN bodies like FAO, WHO, UNICEF and others), or regional development banks, global think tanks like ODI as well as private non-government organisations.

### § 3 Recommended prior knowledge

<sup>1</sup>In the Master's programme, it is very beneficial in particular to have established knowledge of the English language, mathematics, statistics and computer skills. <sup>2</sup>Students whose credits in mathematics and statistics were not better than satisfactory in the course of their preliminary studies, and whose English and/or computer skills are low, are recommended to qualify themselves appropriately before taking on the Master's programme.

## § 4 Structure of the academic programme, contents of study and course of studies

(1) <sup>1</sup>The 120 C to be completed in the Master's degree programme in Development Economics in a standard period of study of four semesters are made up as follows:

- (2) <sup>1</sup>Admission to write the master's thesis is conditional upon earning 18 C from the compulsory part of the programme and 6 C which shall be by successfully completing a seminar course in the compulsory elective subjects. <sup>2</sup>Time to complete the thesis is 20 weeks. <sup>3</sup>30 credits are awarded for successful completion of the master's thesis.
- (3) <sup>1</sup>Study abroad for at least one semester at a foreign university is an integral part of the Master's programme "Development Economics" for students who have acquired their university entrance qualification in the Federal Republic of Germany or in a country or a region in which German is the official language. <sup>2</sup>During the stay abroad, study and examination components with a rating of 30 C should be completed as a rule; however, completion of components with a rating of at least 18 C should be proven and provided. <sup>3</sup>The components must correspond essentially to the qualification standard of a Master's programme and may not be part of a module exam that has been passed or pending completion as part of this degree programme before the stay abroad. <sup>4</sup>Transfer of examination components can be stipulated by conclusion of a "learning agreement" before the stay abroad. 5Upon application, the Examination Board may release students from the obligation to spend a period abroad if they have already provided evidence of a period abroad in the previous degree programme; evidence is provided if at least 18 C have been acquired during the period abroad and have been included in this degree programme. <sup>6</sup>Exemption is also possible if the stay abroad is intended as part of the field research for the master's thesis and this is confirmed by the academic advisor for the master's thesis. <sup>7</sup>Failed examination components as part of compulsory study abroad at a foreign university can be retaken at the University of Göttingen.
- (4) Appendix V shows a schematic overview of the course of the Master's programme "Development Economics".

#### § 5 Amendments

<sup>1</sup>Amendments to these examination and study regulations will be decided on by the Faculty Council of the Faculty of Economic Sciences. <sup>2</sup>Before any corresponding resolutions are passed, the Faculty Council of the Faculty of Agricultural Economy must be given suitable opportunity for deliberations.

#### § 6 Double Degree with the University of Stellenbosch

- (1) <sup>1</sup>The University of Göttingen and the University of Stellenbosch join hands to conduct a double degree programme. <sup>2</sup>The provisions of these examination and study regulations shall apply, provided that the following does not stipulate any other procedure. <sup>3</sup>The regulations in place at the University of Stellenbosch shall apply exclusively to the modules offered by the University of Stellenbosch.
- (2) Students at the Master's programme "Development Economics" are eligible to take part in this programme in accordance with the provisions laid down in the following regulations.
- (3) <sup>1</sup>A selection procedure will be carried out for the 5 places allocated to the students in the Master's programme "Development Economics". <sup>2</sup>The selection committee consists of the person responsible for the Master's programme "Development Economics", the double degree coordinator and one teaching member of the faculty group at the Faculty of Economic Sciences; one member of the student body will also be included in an advisory capacity. <sup>3</sup>The member of the faculty group and the student body will be appointed by the corresponding faculty representation on the Faculty Council at the Faculty of Economic Sciences.
- (4) <sup>1</sup>The application for inclusion in the double degree programme must be submitted to the Dean's Office at the Faulty of Economic Sciences by no later than May 15. <sup>2</sup>The following documents must be enclosed with the application:
  - the diploma from the applicant's previous degree programme in the form of certified copies or certified English translations; in the event that a diploma has not yet been received, students must submit certification of the modules completed, the credits and the average grade, along with an assessment of the thesis completed in the previous degree course.
  - modules completed in economics and/or agricultural economics in an accumulated scope of at least 60 credits;
  - modules completed in economic theory, agricultural economics and development economics in an accumulated scope of at least 30 credits;
  - a written presentation in the English language, detailing the applicant's motivation for inclusion in the double degree programme and the aims of his or her studies and
  - a curriculum vitae in tabular form and in the English language, detailing concisely the educational path that demonstrates which practical professional skills and other specialist qualifications or periods spent abroad the applicant is able to present.
- (5) The selection committee in the degree programme makes its selection on the basis of the following criteria.
  - a) The following qualifications for entry shall apply:
    - aa) The grade for the thesis in the previous degree programme must be at least 2.50;
    - bb) The overall grade in the modules completed in economics and/or agricultural economics with an accumulated scope of at least 60 credits must be at least 2.50;
    - cc) Knowledge accumulated in modules in development economics and agricultural economics must be proven with a scope of at least 10 C.

- b) Selection of the applicants who are eligible in accordance with the criteria laid down in a) will take place on the basis of a points scale. These points will be awarded according to the following criteria.

- (8) ¹All students participating in the double degree programme with the University of Stellenbosch must successfully complete their master's thesis with a scope of 30 C. ²The academic advisers for the master's thesis will be one examiner at the University of Göttingen and one examiner at the University of Stellenbosch. ³The master's thesis must be written in English. ⁴In the event that the master's thesis is completed at the University of Stellenbosch, the examination regulations in force at the University of Stellenbosch shall apply to admission, supervision and assessment. ⁵The academic adviser, resp. the evaluator from Göttingen must be an authorised examiner at the University of Göttingen; following notification by the University of Stellenbosch, they are appointed by the Examinations Office at the Faculty of Economic Sciences. ⁶In the event that the master's thesis is completed at the University of Göttingen, the examination and study regulations in force there shall apply. ⁿIn such cases, the regulation given in § 4 section 2 sentence 1 does not apply, that is, the successful completion of the seminar from the compulsory elective subjects is not required for the admission to the master's thesis.
- (9) Following successful completion of the master examination, the University of Göttingen awards the university degree "Master of Science (M.Sc.)" and the University of Stellenbosch awards the university degree "Master of Commerce (MComm)".
- (10) <sup>1</sup>Each university will issue a degree certificate for the university degree they award, whereby the two degree certificates are integrated in such a way as to represent one single degree certificate in terms of content. <sup>2</sup>The degree certificate can only be issued in an integrated form. <sup>3</sup>The University of Göttingen issues the degree certificate in the English or on request the German language with the date of certificate; in addition to stating the degree programme, the degree certificate also specifies the bi-national structure.
- (11) <sup>1</sup>The two university degrees can be listed as separate titles. <sup>2</sup>In the event that both university degrees are listed as titles, they shall be connected by a hyphen; the same applies to the abbreviated form. <sup>3</sup>This does not affect the statutory provisions concerning the use of titles from foreign universities.

#### § 6 a Double Degree with the University of Florence

- (1) <sup>1</sup>The University of Göttingen and the University of Florence join hands to conduct a double degree programme. <sup>2</sup>The provisions of these examination and study regulations shall apply, provided that the following does not stipulate any other procedure. <sup>3</sup>For examination and study components that are offered by the University of Florence, the provisions of the University of Florence apply exclusively.
- (2) Students at the Master's programme "Development Economics" are eligible to take part in this programme in accordance with the provisions laid down in the following regulations.

- (3) <sup>1</sup>A selection procedure is conducted for the 5 seats available at the University of Göttingen each year for students of the Master's degree programme "Development Economics". <sup>2</sup>The selection committee consists of the person responsible for the Master's programme "Development Economics", the double degree coordinator and one teaching member of the faculty group at the Faculty of Economic Sciences; one member of the student body will also be included in an advisory capacity. <sup>3</sup>The member of the faculty group and the student body will be appointed by the corresponding faculty representation on the Faculty Council at the Faculty of Economic Sciences.
- (4) <sup>1</sup>The application for inclusion in the double degree programme must be submitted to the Dean's Office at the Faulty of Economic Sciences by no later than May 15. <sup>2</sup>The following documents must be enclosed with the application:
  - the diploma from the applicant's previous degree programme in the form of certified copies or certified English translations; in the event that a diploma has not yet been received, students must submit certification of the modules completed, the credits and the average grade, along with an assessment of the thesis completed in the previous degree course.

- (5) The selection committee in the degree programme makes its selection on the basis of the following criteria.

    - aa) The grade for the thesis in the previous degree programme must be at least 2.50;
    - bb) the current average grade of the achievements proved in Macroeconomics, Mathematics, Statistics, Econometrics, Agricultural Economics, Economic Geography and Economic History to the extent of a total of at least 60 credits is at least 2.50.
    - cc) the current average grade in the additionally proved achievement in Mathematics, Statistics and Econometrics to the extent of a total of at least 12 credits is at least 2.50.
  - b) Selection of the applicants who are eligible in accordance with the criteria laid down in a) will take place on the basis of a points scale. These points will be awarded according to the following criteria.

- (9) <sup>1</sup>The examination regulations of the university at which the student is spending the fourth semester apply exclusively to the preparation of the Master's thesis. <sup>2</sup>If an authorised examiner from the University of Göttingen is involved in the examination procedure at the Université Clermont Auvergne, he or she will be appointed by the Examinations Office of the Faculty of Business and Economics after notification by the Université Clermont Auvergne.
- (10) <sup>1</sup>Following successful completion of the master examination, the University of Göttingen awards the university degree "Master of Science (M.Sc.)" and the Université Clermont Auvergne awards the university degree "Master en Economie du Dévelopment, parcours

Development Economics". <sup>2</sup>Both the university degrees can be used as separate titles. <sup>3</sup>In the event that both university degrees are listed as titles, they shall be connected by a hyphen.

(11) <sup>1</sup>The Master's degree certificate of the University of Göttingen is issued in English or on application in German and includes the addendum, that the Master's degree was acquired as a part of the double degree programme.

# § 7 Entry into force

- (1) The regulation enters into force following its promulgation in the Official Announcements of Georg-August-Universität Göttingen as per 01.04.2012.
- (2) At the same time, the examination regulations for the Master's degree programme "Development Economics" in the version contained in the announcement dated 30.09.2011 (Official Announcements I no. 8/2011 S. 470) and the study regulations for the Master's degree programme "Development Economics" in the version contained in the announcement dated 30.09.2011 (Official Announcements I no. 8/2011 S. 475) shall cease to be effective.

<sup>3</sup>This decision as specified under letter b) is possible especially in cases in which a module examination can be retaken or a compulsory module has been changed substantially or removed. <sup>4</sup>The examination board can draw up general rules for this purpose. <sup>5</sup>Modules and periods of studies completed before these study and examination regulations come into force remain unaffected. <sup>6</sup>Examinations based on regulations valid before these examination and study regulations came into force will be held for the last time in the summer semester of 2014.


